## The Northern Rhodesia Order in Council, 1957

### The Queen's Most Excellent Majesty in Council

Her Majesty, by virtue and in exercise of the powers in that behalf by the Foreign Jurisdiction Act, 1890(a), or otherwise in Her Majesty vested, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows :—

### Citation, construction and commencement

1.—(1) This Order may be cited as the Northern Rhodesia Order in Council, 1957, and shall be read and construed as one with the Northern Rhodesia Orders in Council, 1924 to 1954.

(2) The Northern Rhodesia Orders in Council, 1924 to 1954, and this Order may be cited together as the Northern Rhodesia Orders in Council, 1924 to 1957.

(3) This Order shall come into operation on the 30th day of August, 1957, and shall be published in the Gazette.

## Amendment of Northern Rhodesia Order in Council, 1924

2. Article 43 of the Northern Rhodesia Order in Council, 1924(b), as amended by the Orders in Council mentioned in the Schedule to this Order, is hereby amended as follows :--

(i) there is hereby substituted for subparagraph (a) of paragraph (1) the following subparagraph—

"(a) except as provided by subparagraph (b) of this paragraph no native shall be removed from any kraal, or from land assigned to him under native customary law for occupation, except after full enquiry by, and by order of the Governor.";

- (ii) in subparagraph (b) of paragraph (1) the words "under native customary law" are hereby inserted immediately before the words "for occupation";
- (iii) in paragraph (2) the words "land assigned to him under native customary law for occupation" are hereby substituted for the words "any land".

### EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to indicate its general purport.)

The Northern Rhodesia Order in Council, 1924, provides that a native cannot be removed from any land assigned to him for occupation except by order of the Governor. This Order confines that prohibition to cases where land has been assigned to natives for occupation under native customary law.

## The River Purification Authority (Commencement No. 9) **Order.** 1957

In exercise of the powers conferred upon me by subsection (3) of section 2, and subsection (4) of section 36 of the Rivers (Prevention of Pollution) (Scotland) Act, 1951(d), and of all other powers enabling me in that behalf, I hereby order as follows:-

1. This Order may be cited as the River Purification Authority (Com-mencement No. 9) Order, 1957, and shall come into operation on the first day of October, 1957.

2.—(1) In this Order—

"Act " means the Rivers (Prevention of Pollution) (Scotland) Act, 1951; "Board" and "Board Area" mean respectively the Dee and Don River Purification Board established, and the Dee and Don River Purification Board Area defined, by the Dee and Don River Purification Board (Area and Establishment) Order, 1954(e).

(2) The Interpretation Act, 1889(f), shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

3.-(1) The Board shall commence on the first day of October, 1957. to exercise within the Board Area the functions conferred by the Act on a river purification authority.
